As per Regulation 27(2) of the SEBI (Listing Obligation and Disclosure Requirements) regulations, 2015 compliance with the corporate governance shall not apply in respect of –

a) the listed entity having paid up equity share capital not exceeding rupees ten cores and net worth not exceeding rupees twenty five cores, as on the last day of the previous financial year as on 31.03.2021.
