With reference to captioned subject we would like to inform you that,

As per Regulation 27(2) of the SEBI (Listing Obligation and Disclosure Requirements) regulations, 2015 compliance with the corporate governance shall not apply in respect of –

- a) The listed entity having paid up equity share capital not exceeding rupees ten cores and net worth not exceeding rupees twenty five cores, as on the last day of the previous financial year as on 31.03.2019.

Therefore the compliance with the corporate governance shall not apply to our company, as the paid up equity capital was below Rs. 10 Crores and net worth was below Rs. 25 Crores, as on the last day of the previous financial year. 


